Introduction

National Program Benchmarks (NPB) for Secondary (Grades 9-12) Agriculture, Food, and Natural Resource Education

The National Council for Agricultural Education has provided permission to the National FFA Organization for the use of the National Program Benchmarks for Agriculture, Food and Natural Resource Education in the development of their educational resource materials. The National Council for Agricultural Education is the owner and developer of the National Program Benchmarks for Agriculture, Food, and Natural Resource Education © 2025 and reserves all rights to the original material that is used here with permission. The National Program Benchmarks (NPB) for Secondary (Grades 9-12) Agriculture, Food, and Natural Resource Education is a tool designed for local agriculture, food, and natural resource education programs to analyze their program and develop clear goals and objectives for program growth. This tool is designed to be used by local teacher(s) in cooperation with administrators, community partners, advisory committees, FFA support groups, and/or an external assessment team. These benchmarks reflect all components of an agriculture, food, and natural resource education program, including:

- ▶ Classroom and laboratory instruction
- ▶ Work-Based Learning (referred to in this document as “Experiential, project, and work-based learning through SAE”)
- ▶ Career and Technical Student Organization (referred to as “Leadership and personal development through FFA”)

The FFA/Leadership & Personal Development Benchmarks include:

1. The program operates an FFA chapter that is in good standing with state and national organizations.
2. Students build a progressive leadership and personal development plan.
3. The agriculture program offers diverse personal and leadership development activities to engage all students (e.g., classroom and laboratory instruction, experiential, project, and work-based learning through SAE, and leadership and personal development through FFA).
4. The FFA chapter constitution and bylaws are up to date, reviewed annually and approved by chapter members as needed.
5. FFA members are involved in the planning and implementation of a Program of Activities (POA).
6. The FFA Chapter conducts regularly scheduled chapter meetings.
7. An awards recognition program planned and conducted by FFA members is in place.
8. The FFA Chapter operates a current budget, which provides the financial resources to support the Program of Activities (POA) and operates in alignment with local school district requirements.
9. A strategic student-driven marketing effort is in place to promote the FFA Chapter to the community and appropriate stakeholders.
10. Key stakeholders are regularly informed regarding the goals, objectives, activities, and accomplishments of the FFA program.
11. Students partner with the community to develop networks, leadership, and in-service opportunities to foster civic engagement.

The NPB is part of the process of being awarded the State Superior FFA Chapter Award. The maximum score on the NPB Section of the State Superior FFA Chapter Award Application is 22 points. A minimum of 17 points or higher, in addition to the activity name and descriptions, must be earned and completed for a chapter to fill out the National FFA Chapter Award Application (formerly Form II). Specifically, the State Superior FFA Chapter Award Application requires chapters to showcase one activity related to each of the 15 Program of Activity (POA) Standards.

Goals for Chapter Activities

Chapter activities should provide the following:

- A balance of experiences inside and outside the classroom.
- Opportunities for developing self-confidence, responsibility, citizenship, cooperation, and leadership skills.
- Authentic, engaging activities.
- Relevant, educational experiences.
- Accessibility for all students.
- Flexibility that will allow chapters from various environments and with various levels of resources to be successful.
- Multiple levels of participation and experiences.
- Appropriate recognition for all participants.
- Exposure to opportunities and educational experiences in food, agriculture, and natural resources.

Purpose of a Program of Activities

The purpose of an FFA Program of Activities (POA) is to provide a structured, written guide for an FFA chapter's activities throughout the year. It defines chapter goals, outlines steps to achieve those goals, and serves as a reference point for members, administrators, advisory committees, and other stakeholders. The POA helps ensure that chapter activities are focused on growing leaders, building communities, and strengthening agriculture, while also providing a framework for student leadership development and budget management.

Chapter activities should provide the following:

1. A balance of experiences inside and outside the classroom.
2. Opportunities for developing self-confidence, responsibility, citizenship, cooperation, and leadership skills.
3. Authentic, engaging activities.
4. Relevant, educational experiences.
5. Accessibility for all students.
6. Flexibility that will allow chapters from various environments and with various levels of resources to be successful.
7. Multiple levels of participation and experiences.
8. Appropriate recognition for all participants.
9. Exposure to opportunities and educational experiences in food, agriculture, and natural resources.

FFA Mission: FFA makes a positive difference in the lives of students by developing their potential for premier leadership, personal growth, and career success through agricultural education.

FFA Vision: FFA provides the next generation of leaders who will change the world.

The FFA mission is **what** the organization does. The FFA vision is **why** the organization does it. By delivering this process, FFA grows leaders, builds communities, and strengthens agriculture.

Each chapter builds its POA around three Divisions. Divisions focus on the types of activities a chapter conducts. The three Divisions include:

- Growing Leaders.
- Building Communities.
- Strengthening Agriculture.

Each Division in the POA has five Program of Activity (POA) Standards. Superior chapters conduct activities that relate to each of the Program of Activity (POA) Standards.

Program of Activity (POA) Standards

Fundraisers benefiting the chapter—such as fruit sales, plant sales and meat sales—are not part of the National FFA Chapter application, as there is no Program of Activity (POA) Standard that aligns with this type of activity. Activities such as benefits or charity events that benefit community members or the community should be used under the Citizenship Program of Activity (POA) Standard.

Growing Leaders: Encourages chapters to focus on developing individual skills, leadership qualities, and personal growth among members. This pillar evaluates how chapters create opportunities for members to grow in leadership abilities, academic achievement, character development, and career readiness.

Scholarship awards, tutoring, elementary reading programs, school, and college tours, FFA scholarships, leadership conference scholarships, study skills seminars for members, chapter/school honor roll and recognition for students across school departments, academic mentoring	Scholarship: Activities that develop a positive attitude toward lifelong learning experiences.
Time management activities, self-help workshops, facing your fears, money management, financial planning, anti-bullying, diversity/inclusion programs, personal organization skills, member degrees	Personal Growth: Activities conducted that improve the identity and self-awareness of members. These activities should reflect members' unique talents and potential by reinforcing their human and employability skills. The activities should strive to enhance the quality of life and contribute to members' life goals and development.
News stories, career day, guest speakers, displays of exemplary programs, facility tours, mentor programs, international seminars, shadow experiences, agricultural skills and judging events, test plots for the school agriculture department, agriscience fairs, science fairs for elementary students, computer literacy activities, SAE tours, SAE fairs	Career Success: Activities that promote student involvement and growth through agriculture-related experiences and/or entrepreneurship and promote career readiness.

Building Communities: Encourages chapters to engage with and contribute positively to their local communities. This pillar evaluates how chapters create opportunities for members to engage in activities that promote civic responsibility, environmental stewardship, and community development. Members demonstrate their ability to assess local needs, collaborate with community stakeholders, and implement initiatives that foster social, economic, and environmental progress.

Urban and rural conservation programs, collaborative efforts to raise game for release/biological control, water and air quality programs, green practices, provide water testing, recycling programs, National FFA Living to Serve Grants	Environmental: Activities conducted to preserve natural resources and develop more environmentally responsible individuals.
PALS (Partners in Active Learning Support), special populations involvement, at-risk programs, cultural awareness, and diversity programs, provide an after-school program for younger children, set up a community garden, food/toy drives, National FFA Living to Serve Grants, Farm to School Initiative	Human Resources: Activities conducted to improve the welfare and well-being of members and citizens of the community.
Volunteerism, community service, civic duties, internships with government agencies, roadside/area cleanup, legislative breakfasts, work with local chamber of commerce, organize a charity concert, networking with governmental agencies	Citizenship: Activities conducted to encourage members to become active, involved citizens of their school, community, and country.

Member entrepreneurship, community scavenger hunt, enhanced tourism, international development, historical preservation and community relations, SAE economic impact	Economic Development: Activities conducted to improve the economic welfare of the community.

Strengthening Agriculture: Encourages chapters to promote agricultural literacy, advocacy, and safety within agriculture-related fields. This pillar evaluates how chapters create opportunities for members to advocate for and support agriculture through educational initiatives, hands-on experiences, and community outreach. Members demonstrate their ability to promote agricultural literacy, advance sustainable and safe practices, and contribute to the future success of the agriculture industry through recruitment.

Food for America, Agriculture in the Classroom, Food Checkout Day, activities centered around national food promotions (i.e., dairy month), agriculturally related educational events and/or displays, educating consumers about hunger, food cost and food safety, Our Food Link activities, Food, Land & People, partnering with local fair or festival boards to include food-related educational components in events, alternative fuel education, product awareness as it relates to agriculture (i.e., clothing, medicines, paper, etc.)	Agricultural Literacy refers to the understanding of basic concepts related to agriculture, including its processes, history, and importance to society and the economy. The purpose of agricultural literacy is to educate individuals, especially those with little or no direct connection to agriculture, about how agriculture impacts their daily lives. Students within the chapter might target their efforts toward other students, educators, consumers, and the general public. ##

Agricultural advocacy often builds upon agricultural literacy. Agricultural advocates rely on a foundation of agricultural literacy to effectively communicate the importance of agriculture, address misconceptions, and promote informed decision-making among their audiences.

2. Understanding the Award Program

Program Purpose

The National FFA Chapter Award Program is designed to recognize and incentivize FFA chapters for implementing the organization's mission and strategies, particularly in the 15 Standards of Growing Leaders, Building Communities, and Strengthening Agriculture Divisions. This award encourages chapters to create a well-rounded Program of Activities (POA) and improve their operations based on the National Program Benchmarks (NPB).

Chapter Eligibility

All chapters that are chartered by state FFA associations are eligible for and encouraged to participate in the National FFA Chapter Award Program. Chapters are eligible for recognition in the program each year.

A chapter must also conduct at least one activity related to each of the Program of Activity (POA) Standards and meet the minimum requirements as outlined in the National Program Benchmarks (NPB). The Program of Activity (POA) Standards established for each Division, as well as the National Program Benchmarks (NPB), represent the minimum requirements for the National FFA Chapter Award Program. The Program of Activity (POA) Standards help members select those areas needed to have a successful chapter. States may have other requirements, so check with your state advisor or state FFA officials. To apply for these awards, the chapter must complete the official application and submit it to the state FFA association by the established due date. The application is located in the Application Center on FFA.org.

State Superior FFA Chapter Award Application (formerly Form I)

The State Superior FFA Chapter Award Application (formerly Form I) documents a chapter's activities and demonstrates how it has met the minimum requirements for the National FFA Chapter Award program. It's the foundation for a chapter to be recognized as a State Superior FFA Chapter at the state level and compete for higher state and national awards. The State Superior FFA Chapter Award Application includes a chapter assessment based on the National Program Benchmarks (NPB). The NPB is part of the process of being awarded the State Superior FFA Chapter Award. The maximum score on the NPB Section of the State Superior FFA Chapter Award Application is 22 points. A minimum of 17 points or higher, in addition to the activity names and descriptions, must be earned and completed for a chapter to fill out the National FFA Chapter Award Application (formerly Form II). Specifically, the State Superior FFA Chapter Award Application requires chapters to showcase **one (1) activity** related to each of the POA Standards for a total of **fifteen (15) activities**.

National FFA Chapter Award Application (formerly Form II)

The National FFA Chapter Award Application (formerly Form II) is used by FFA chapters to report their accomplishments and activities, specifically focusing on their Program of Activities (POA). The form allows chapters to demonstrate how they are implementing the FFA mission and strategies, with the goal of achieving state and national recognition. To compete for State Gold, Silver, or Bronze Awards, chapters must qualify for the State Superior FFA Chapter Award (formerly Form I) and complete the National FFA Chapter Award Application. Chapters use the National FFA Chapter Award Application to report on **three (3) activities** for each of the three divisions for a total of **nine (9) activities**. State judges rank the chapters as gold, silver, or bronze based on the rubric. The National FFA Chapter Award Application includes the name of the activity, date the activity was completed, activity description, description of how the activity is related to the quality standard, three goals with plans of action and outcome evaluated and reported for each goal, how the activity advanced leaders, community, or agriculture, the impact, a photo with a caption.

Three C's to Determine Eligibility

1. Chapter in good standing
2. Carried out activity related to each Program of Activity (POA) Standard
3. Completed application

Reasons to Apply

1. Let the public know the chapter's accomplishments
2. Receive recognition for chapter members' efforts
3. Develop pride in your chapter

Awards Available at the State Level

State Superior FFA Chapter Award

Every chapter that meets the minimum National Program Benchmark score and completes the State Superior FFA Chapter Award Application will qualify as a State Superior Chapter. To do this, chapters need to conduct **one (1) activity** related to each Program of Activity (POA) Standard in addition to meeting the minimum criteria outlined in the National Program Benchmarks (NPB).

State Gold, Silver, or Bronze Awards

To compete for state gold, silver or bronze awards, chapters must qualify for the State Superior FFA Chapter Award and complete the National FFA Chapter Award Application. Chapters use the National FFA Chapter Award Application to report goals, plans of action and results/evaluation on three activities for each Division for a total of **nine (9) activities**. State judges rank the chapters as gold, silver or bronze based on the rubric.

Awards Available at the National Level

The number of applications each state may submit depends on the total number of chapters in the state. States may send three applications or the equivalent of 10 percent of the total number of chapters in the state. For example, a state with 150 chapters can submit 15 applications. The number of applications a state can submit will be confirmed in January, prior to when state evaluations begin. Awards will be presented to chapters based on their rating.

National 3,2,1-Star Awards

On the national level, judges rate the chapters as three-star, two-star, or one-star.

National FFA Model of Innovation Activity Awards

The national level also recognizes the top innovative activities in each Division: growing leaders, building communities, and strengthening agriculture. During the application scoring process, judges, using the criterion (see below) for National FFA Model of Innovation Activity, will identify (flag) individual activities to be considered for the National FFA Model of Innovation Activity Awards. From the list of identified (flagged) activities, a committee will select activities to become finalists for the National FFA Model of Innovation Activity. Of those top activities in each Division, a top activity will be chosen in each Division. Only three-star chapters are eligible for the National FFA Model of Innovation Activity Awards.

The criterion for **National FFA Model of Innovation Activity** includes:

1. **Originality of Concept:** Activity is highly unique, never-before-seen, and challenges conventional norms.
2. **Creativity in Execution:** Execution of activity is imaginative, engaging, and full of unexpected elements.
3. **Innovation in Engagement:** Activity introduces new ways to involve participants and spark interaction.
4. **Impact & Memorability:** Activity leaves a lasting impression; participants are likely to talk about it afterward.

National FFA Model of Excellence Chapter Awards

High school chapters will be chosen as National FFA Model of Excellence Chapter Award finalists. These National FFA Model of Excellence Chapter Award finalists exhibit exemplary qualities in **all** categories of growing leaders, building communities, and strengthening agriculture. All **nine (9)** activities will be scored for the National FFA Model of Excellence Chapter Awards. An overall national winner will be chosen from the National FFA Model of Excellence Chapter Award finalists. Only three-star high school chapters are eligible for the National FFA Model of Excellence Chapter Awards.

National FFA Middle School Model of Excellence Chapter Awards

Middle School chapters are selected as National FFA Middle School Model of Excellence Chapter Award Finalists. These National FFA Middle School Model of Excellence Chapter Award finalists exhibit exemplary qualities in **all** categories of growing leaders, building communities, and strengthening agriculture. All **nine (9)** activities will be scored for the National FFA Middle School Model of Excellence Chapter Awards. An overall national winner will be chosen from the National FFA Middle School Model of Excellence Chapter Award finalists. Only three-star middle school chapters are eligible for the National FFA Middle School Model of Excellence Chapter Awards.

For the National FFA Chapter Award Program:

1. High School FFA Chapters will include chapters where students in Grades 10-12 can enroll in agricultural education.
2. Middle School FFA Chapters will include chapters where students in Grades 10-12 cannot enroll in

- agricultural education.
3. Examples:
 - a. Agricultural Education Programs that include Grades 5-8 are eligible for the National FFA Middle School Model of Excellence Chapter Award Program.
 - b. Agricultural Education Programs that include Grades 7-12 are eligible for the National FFA Model of Excellence Chapter Award Program.
 - c. Agricultural Education Programs that include Grades 7-8 are eligible for the National FFA Middle School Model of Excellence Chapter Award Program.
 - d. Agricultural Education Programs that include Grades 7-9 are eligible for the National FFA Middle School Model of Excellence Chapter Award Program.
 - e. Agricultural Education Programs that include Grades 8-12 are eligible for the National FFA Model of Excellence Chapter Program.

National Finalists Selection

National Finalist Selection (application judging) takes place in July to determine star ratings and national finalists for the National FFA Model of Innovation Activity Awards, National FFA Middle School Model of Excellence Chapter Awards and National FFA Model of Excellence Chapter Awards.

National Finalists Presentations and Interviews

National finalists will present and interview during the annual national convention. Details about the National Finalist presentations can be found on pages 19 and 20. The application score will contribute 25% of the overall score, and the presentation and interview will contribute 75%.

National Finalists Scoring:

The application score will contribute 25% of the overall score, and the presentation and interview will contribute 75%.

Scoring for the **National FFA Model of Innovation Activity** will use the following formula:

National Convention Recognition

All national finalists will be recognized on the main stage during the general convention sessions.

Application Deadlines

Applications must be approved online by July 1 to the National FFA Organization.

Applications should be submitted to state FFA officials in accordance with policies established by the state FFA association for judging. Applications must be submitted only on the official application, which is located in the Application Center on [FFA.org](https://www.ffa.org). To determine the deadline in your state, ask your state advisor or state FFA officials. Application deadlines vary from state to state. Applications must be submitted to the state FFA association for approval and must be certified for accuracy by the local chapter advisor. Chapters applying for national star consideration need to submit both the State Superior FFA Chapter Award Application and the National FFA Chapter Award Application.

If a chapter does not want to be considered as a national finalist, the chapter advisor must email nationalchapter@ffa.org by July 1. State staff should also be in communication with those chapter advisors that do not wish to be considered as a national finalist.

3. Applying for Awards

Guidelines for Completing the Application

- Read all of the instructions before beginning.
- Use the latest version of the application located in the Application Center on FFA.org.
- Proofread the final version of the application before submitting. Double-check for spelling and grammatical errors.
- Use the “Tab” key to go to the next cell that will accept information on any page of the application.
- The application saves as you go.
- A National FFA Chapter Award application must result from the student(s) effort and ability.
- **Original Content Required:** A new application must be completed each year. Applications may include the same activity from a previous year, but goals, plans of action, results and evaluation must differ.
- Applications may not
 - Re-submit an activity copied verbatim and pasted from previous years or other FFA Chapters with only minor changes.
 - In any way, falsify information.
 - Use another person’s thoughts as their own, even with this person’s permission. This includes work done by a family member or a mentor.
 - Use information obtained from the internet without proper citation.
- If it is deemed that an application is not original, the application will not be considered a 3-star chapter.

What is an Activity?

An Activity is a single, specific action or task undertaken as part of a larger program or goal. An Activity is often smaller in scale and focused on a particular objective.

Examples of Activities:

- Hosting a leadership workshop for a small group of members.
- Conducting a survey to identify community needs.
- Distributing agricultural literacy materials to local schools.

In contrast, an Event is a broader, organized gathering or occasion involving multiple Activities or efforts aimed at achieving a significant goal or impact. Events are typically, larger in scope and may involve multiple stakeholders. Events are often the culmination of planning and several Activities.

Examples of Events:

- A full-day career fair featuring workshops, guest speakers, and booths.
- A community clean-up drive involving multiple teams and stations.
- An agricultural festival with demonstrations, educational sessions, and exhibits.

Key differences between an Activity and an Event:

- Scale and Complexity: Activities are individual tasks or initiatives, while Events are comprehensive gatherings that might include multiple interconnected Activities.
- Purpose: Activities often serve as steps toward accomplishing the broader objectives of an Event.

The National FFA Chapter Award Program application is designed to collect information about one Activity related to each of the Program of Activity (POA) Standards. If multiple Activities are included in the Activity Description for an Activity, no points will be given for the Activity Description line of the Application Rubric.

Other Submission Processes (State or Local Submission)

- Any version number is acceptable on the cover page and photo pages. Version numbers on all other pages must be the same throughout the application at the time of submission. If version numbers differ throughout the application, the application will be ranked as a participant.
- Font type, size and length of sections are limited by the online application. Altering the application will result in the application being disqualified. Altering the application includes copying the application into a Word document, altering the space given or character limits, and altering the font type or size including bold, underline, italicize or change in color of the text in the application.

Assign Students

- A chapter's application must be started or initiated by the Chapter/Instructor's account from the FFA.org Application Center. After this, the application can be assigned to one or more students on the "Assign Students" page. Students' access can be removed using the same page in the application. If your student does not show in the drop-down menu, confirm that they are listed and submitted to the state on your chapter roster.
- Using the dropdown menu, a list of all students in the chapter is available to assign access. If a student is missing from this menu, contact nationalchapter@ffa.org.
- The assigned students have complete access to edit, update and delete all information contained in the application.
- Students should avoid working on the same screen at the same time.

Cover Page

- The beginning date of the application should be the date that the chapter's Program of Activities begins. It may be a prescribed date in your state. Check with your state advisor.
- The difference between the beginning and ending dates of the application will be one year. The end date is calculated when the user clicks "Set Dates" after entering the Beginning Date for Activities.
- The Beginning Date for Activities should be no earlier than Jan. 1 of the previous convention year. For example, if the "Convention Year for this Application" is 2027, the "Beginning Date for Activities" should be no earlier than Jan. 1, 2026. If the incorrect year is on the application cover page, the application will be ranked as a participant.

Completing the State Superior FFA Chapter Award Application

- Contains a brief description of an activity within each Program of Activity (POA) Standard and a chapter assessment based on the National Program Benchmarks (NPB).

Activities

- Include a brief description of an activity within each Program of Activity (POA) Standard.
- A maximum of 350 characters per Program of Activity (POA) Standards is permitted with the exception of:
 - Plan of Action – 450 maximum
 - Outcomes – 200 maximum
 - Advancing Leaders – 500 maximum
 - Impact – 500 maximum

Indicators

- The application includes a chapter assessment based on the National Program Benchmarks (NPB). The NPB scale is used to determine if a chapter will be awarded the State Superior FFA Chapter Award. The maximum score on the State Superior FFA Chapter Award Application is 22 points. A minimum of 17 points or higher in addition to the activity summaries must be earned and completed in order for a chapter to fill out the National FFA Chapter Award Application.

Summary

- This page in the application serves as a summary sheet for all information entered on the “State Superior FFA Chapter Award Application Indicators” page.
- The National FFA Chapter Award Application becomes available once the minimum qualifications are met in the State Superior FFA Chapter Award Application.

Completing the National FFA Chapter Award Application

- The National FFA Chapter Award Application requires the chapter to select, list and describe three major activities conducted for each Division. These activities should be activities listed in the State Superior FFA Chapter Award Application. The chapter can use an activity once in the National FFA Chapter Award Application.
- After selecting the activities, the chapter must describe the goals, plan of action and results/evaluation for each activity.
- All text boxes in the application are character counted. All text boxes allow unlimited text during the editing process, but a character count is available to help the chapter understand the parameters. The Checklist at the end of the application will provide validation on missing or too-long responses.
- “Check Spelling” is available on all the National FFA Chapter Award Application pages.
- A user can hard-return. By pressing enter within a text box, it will begin a new line.
- The chapter needs to include a photo and caption for each activity. Good photographs and captions increase the impact of the application. Keep the following points in mind when taking and captioning photos:
 - Do not stage the pictures. Take photos throughout the activity and select the best ones.
 - Appoint a member to be responsible for photographing each activity.
 - Be sure the photographer knows how to use the camera. Photos that are not well-exposed are generally too dark or grainy.
 - Plan your pictures; do not just point and shoot.
 - Move as close to your subject as possible.
 - One photo, not a collage or screenshot, should be submitted with each activity. If a collage or screenshot is used, 0 points for Photo will be awarded on the rubric.
 - Captions should do more than just name the picture. They should be informative and interesting.
 - Photos should be formatted:
 - Landscape
 - Aspect ratio: 4x3
 - Resolution: 1024x768 or 4000x3000
 - Photos must be of the chapter activity. Misleading or falsified photos may lead to disqualification.

Check sheet

- The Check sheet provides warnings for incomplete information.
- Warnings and messages will not prevent the generation of the PDF application. Chapters are strongly encouraged to correct all errors before submitting the application.

Electronic Signatures

- The signature screen is available online when the Checklist is fully met
- Students should complete all other pages of this application before obtaining electronic signatures

National FFA Organization

- if this application undergoes significant changes after signing, the signatures should be reobtained using this form by clicking “revoke signature.”
- Please review the entire application, and electronically sign the appropriate section.
- If a section is not available, your user account’s Role does not grant access to that section.

Submit Application

- Chapters have two options:
 - Complete/Save Your Application — This will generate all pages in the State Superior FFA Chapter Award Application and the National FFA Chapter Award Application for a complete chapter application. This is for chapters interested in competing for state gold, silver, or bronze awards as well as national 3-, 2- and 1-star awards. By selecting this option, a PDF export is generated of the State Superior FFA Chapter Award Application and the National FFA Chapter Award Application pages.
 - Completing the State Superior FFA Chapter Award Application and the National FFA Chapter Award Application are needed to be considered for national judging.
 - Generate the State Superior FFA Chapter Award Application only — This is intended for chapters who are only interested in being recognized for the State Superior FFA Chapter Award. Some states may use this as a reporting form for other purposes. Check with your state advisor for more details. By selecting this option, a PDF export is generated of the State Superior FFA Chapter Award Application pages.
 - Chapters and states are also able to see earlier versions of the application that was previously saved.
 - State associations are responsible for submitting the state applications. All applications are submitted as PDFs through the online approval portal.

Professional Integrity

FFA members participating in national FFA programs and events understand and agree that all work must result from their own effort and ability, created, and completed alone (except for partner or chapter applications). When outside sources (direct quotes or phrases, specific dates, figures, or other materials) are used for a project, document, or application, the required reference citation must be completed according to the rules specified by the applicable handbook.

While participating in National FFA programs, FFA members are prohibited from:

- Plagiarizing
- Violating copyright
- Cheating
- Falsifying information
- Using another person’s results or thoughts as their own, even with this person’s permission. This includes work done by a family member or a mentor.
- Using information or data obtained from the internet without proper citation.

Any attempt to gain an unfair advantage will not be tolerated. Non-compliance represents plagiarism and will automatically disqualify a member.

Use of Artificial Intelligence (AI) for National Programs and Events

Artificial intelligence (AI) refers to computer systems capable of performing complex tasks that historically only a human could do, such as reasoning, making decisions, or solving problems. As AI continues to evolve, it can be a tremendous tool to help companies, organizations and individuals enhance their productivity and work. Therefore, the National FFA Organization allows the use of AI tools. FFA members may use AI tools, such as ChatGPT, Gemini, and CoPilot, to assist them in their learning.

Appropriate uses of AI may include:

- generating ideas for any FFA-related assignments, projects, contests, and award applications
- checking facts of a phenomenon
- checking for and correcting grammatical errors in a paper written by a member

For consideration as a State Superior FFA Chapter, the chapter must complete the State Superior FFA Chapter Award Application. The State Superior FFA Chapter Award Application is not scored at the national level. The State Superior FFA Chapter Award Application is composed of two sections:

- Verification that the chapter POA addresses the Program of Activity (POA) Standards related to growing leaders, building communities, and strengthening agriculture by providing a brief summary of one activity per Program of Activity (POA) Standards.
- Fulfillment, development, and growth of the National Program Benchmarks (NPB).
